

FREE GIFT PROMOTION OFFICIAL RULES

VF International SAGL whose registered office is in Via Laveggio 5- 6855 Stabio, Switzerland VAT CHE-111.650.898 (hereinafter referred to as the "**Promotion Company**"), in cooperation with VF NORTHERN Europe Limited, whose company registration number is SC047368 and registered office is at C/O Brodies LLP Capital Square, 58 Morrison Street, Edinburgh, EH3 8BP, is organizing free gift promotion called “SHOP.SKATE.CELEBRATE” (the "**Promotion**").

Promotion period

The promotion runs from 18/12/2023 to 31/12/2023 (the "**Promotion Period**").

Eligibility

Entry into this Promotion is open only to the UK residents, (the "**Participant/s**") that during the Promotion Period make a minimum purchase of £100.00 in one of the following Vans participating stores:

How to enter
